President's Note: Armistice day or Veterans day

While researching in Washington, D.C. I took a break to tour Arlington National Cemetery. I usually spend a few moments at the Tomb of the Unknown Soldier. I'm sure everyone is familiar with this monument, but there are also other Tombs of the Unknowns in the United States: Tomb of the Unknown Revolutionary War Soldier in Washington Square, Philadelphia; Civil War Unknowns Monument, Arlington National Cemetery; and Tomb of the Unknown Confederate Soldier at Beauvour in Biloxi, Mississippi. Here a few facts regarding the soldiers who guard the most visited Tomb.

The Tomb has been guarded by a Sentinel continuously (every minute, day and night) since 1937, including during terrorist attacks and hurricanes. They must pass a series of tests. After serving 9 months as a Sentinel at the Tomb, he,or she (there have been three female Sentinels) receive the Tomb Guard Identification Badge, the second rarest award currently issued in the United States Army; only the Army Astronaut Badge is rarer. Since the first award in 1958, only about 600 soldiers have completed training and been awarded this Badge.

A Guard takes six to eight hours to prepare his uniform — heavy wool, regardless of the time of year — for the next day's work. His gloves are moistened to improve his grip on the rifle.

The Guard takes 21 steps across the mat. This alludes to the twenty-one gun salute, which is the highest honor given any military or foreign dignitary. He stops on the 21st step, then turns and faces the Tomb for 21 seconds. Then he turns to face back down the mat, changes his weapon to the outside shoulder, counts 21 seconds, and then steps off for another 21 step walk down the mat. He faces the Tomb at each end of the 21 step walk for 21 seconds. The

Sentinel then repeats this over and over until he is relieved at the Guard Change.

The mat is replaced twice each year: before Memorial Day and before Veterans Day. This is required because of the wear on the rubber mat by the special shoes worn by Tomb Guards. On the ground not covered by the mat, a wear pattern in the tile can be seen that corresponds to the precise steps taken during the changing of the guard.

The Guard is changed every thirty minutes during the summer (April 1 to Sep 30) and every hour during the winter (Oct 1 to Mar 31). During the hours the cemetery is closed, the guard is changed every 2 hours.

The guard wears no rank insignia, so as not to outrank the Unknowns, whatever their ranks may have been. The duties of the sentinels are not purely ceremonial. The sentinels will confront people who cross the barriers at the tomb, or are disrespectful or loud.

THE LIFE AND DEATH OF A MICHIGAN CANNONEER

This is an excerpt from the Diary of Thomas Albert Davis.

DIARY OF THOMAS ALBERT DAVIS BATTERY B 1ST MICHIGAN LT. ARTILLERY

THOMAS "ALBERT" DAVIS, b/ 1845 Oct 1; Civil War Service, died in Rome, GA, 1 June 1864 SON OF ISAAC DIXSON DAVIS AND SOPHIA REED

I must stop for I have written this sheet all up.

1864 June 1, Tuesday @ Rome, GA from RHUFUS & HUBBELL, Batt B, 1st Mich Light Art, 3 Brigade, 2 Div, 16 [?] Corp to friend, Mr. Davis {father Isaac Dixon Davis}

I thought I would write you a few lines seeing that I had the opportunity to let you know how we are getting along. We have been marching for the last 25 days of May and have finally stopped to rest. I [?] to have not very good news to impart to you. ALBERT was taken down sick when we stopped. He now lies in the hospital. [RAUFUS?] & myself was down to see him last Sunday and he seemed to feel better. We went and washed his clothes for him. Went down this morning, which is Tuesday, to see him and he was worse. He had been out of his head for the last hour. We are in hopes he will not be sick long for we would like to come home as we went away. We will do all that we possibly can for him. The docter seems to think that he is a little better just now. WILLIAM is not very tough but I guess he will stick it through. [RAULFUS?] and myself never enjoyed better health in the world. It is mighty warm down here but we do not have anything to do so we get in the shade as much as possible. I am in hopes that ALBERT will be all right in a little while. If you should happen to see our folks, tell them that we are all well. No more time but we will write and let you know if he gets any worse. This from [RHUFUS] & HUBBELL. Write soon as you get this.

THOMAS ALBERT DAVIS died on 1 June 1864, the day his friend wrote of his illness.

ENTRY FROM DIARY OF ADELE DAVIS MURRAY, 1874 June 1 -

I desire to say a few words to you tonight, my Journal. This is the tenth anniversary of my dear brother Albert's leath, the companion of my childhood, the one upon who I was wont to look as my surest stay and support. The cruel var called him to a southern grave. I sometimes think he might have felt that I did not sorrow for his going. I was so nxious not to give him unnecessary pain. But we had no sooner left him than I let my tears have way.

May 25 – ROME, GA.

Stayed up around camp. The drivers are down town in a livery with their horses.


