THE ALBION WEEKLY MIRROR 1855, 1856, 1857, 1868 AND 1869 ALBION, MICHIGAN

The following marriages appeared in THE ALBION WEEKLY MIRROR, a local Newspaper published in Albion, Calhoun Co. MI. Only those not found listed in the MARRIAGE RECORDS OF CALHOUN COUNTY, MICHIGAN 1836-1890,—complied by Beverly M. Lancaster, were extracted. In the early years all marriages were not recorded in the State of Michigan records. They may have been recorded in some other county or not at all. Myrta M. PHELPS, md 24 Dec 1901 Walter H. NORTH, who later became Chief Justice of Mich. Supreme Court.

Myrta's maternal. grandmother was Margaret BLASHFIELD, next younger sib of my great grandfather William BLASHFIELD II. Their father, BLASHFIELD, with second wife and family settled in Clarendon Twp. Calhoun Co. MI Territory in 1836. Iddo had eight children by his first marriage with Jane (VANDERLYNE) BLASHFIELD and two daughters Mary Ann and Emma by his second (Hitchcock) Lucinah wife. (Keep) BLASHFIELD.

Margaret married Newman ENOS 13 DEC 1837 and they had six children, the second being Mary Ann ENOS who was Myrta's mother. Known as Ann ENOS as an adult, she married Josiah H. PHELPS on 23 Mar 1870. Both were teachers.

Josiah and Ann PHELPS had a son, Homer E. PHELPS. He is bur with his parents at Oakridge Cemetery in Marshall,

Myrta (Phelps) NORTH and Justice NORTH had four children: Vera, Walter P., Robert H., and Virginia; now all deceased.

Of all ten children of Iddo BLASHFIELD, Margaret has the most descendants.

Ann ENOS attended Homer Academy, Homer MI at the same time her first cousins Adelia and George BLASHFIELD, siblings of my great grandfather William B. BLASHFIELD. Children of William BLASHFIELD II and Alvira (Keep) BLASHFIELD.

CEMETERY PROJECT UPDATE - Ruth Kaiser

We have been able to finish the Cook's Prarie second check and will be printing copies which will be available for the September Annual Meeting. This is an especially old cemetery and has grave sites dating into the early 1830s. We have also found a volunteer for the Revolutionary Army, Elijah Cook. The stone was broken in two pieces and lying on the ground so we had to lift the sod in order to read parts of the inscription. Several years ago one of the members of his family planned to procure a government plaque. However, the sexton related that she was in her 80s at the time and since then nothing has been heard from her. The Charity Cook DAR chapter was named after his wife, who lies in a grave nearby.

Our next project will be the West Clarendon Cemetery which will finish the cemeteries in Clarendon Township. Booklets are currently available for St Joseph and Bentley Corners. Cemetery readings have been scheduled for Wednesdays when Ramona Short is free to assist your chair. It has worked out best for those who are interested in helping to check with me on Tuesdays or Wednesday morning to find out the location and time of meeting or if a cancellation has become necessary.

All the cemeteries in Clarence Township except Clarence Center have been combined into a booklet and are now available to purchase through the CCGS corresponding secretary, Ramona Short. We will work on completing Clarence Center next. In the meantime the first draft in alphabetical order will be placed in the Michigan and Calhoun county libraries.
