The sale of bonds will continue although it is stated that all drives are ended and there will be no more. Many companies are discontinuing the deduction method of purchasing bonds because of the accounting work necessary. A discussion of the subject by your bond committee favored a continuation of the purchase of bonds by the deduction method. Many employees have found this to be an excellent method of saving and the management will be glad to assume the extra duties of accounting for those who desire to still save by the bond deduction method. So from now on, deducting for purchase of bonds will be voluntary on your part. We will be happy to do the work if you wish to keep on saving—if you wish to stop your deduction notify your department timekeeper. In closing we are happy to tell you that since the buying of bonds started Ypsilanti Employees have purchased a total, up to January 1, 1946, of \$580,824.00 of war bonds. Our quota of every bond drive has been exceeded, regular payroll deductions have been highly satisfactory, You are to be complimented on your response to this as well as production effort to successfully close up two wars.
